Council adjourned to Committee of the Whole at 2:37 p.m. and reconvened in the Council Chamber at 7:30 p.m. with all those listed earlier present.

ADOPTION OF MINUTES

1. Motion to adopt the [minutes of the last regular meeting of the City Council held May 28, 2007](#) and [minutes of a Special Open Meeting of City Council held June 5, 2007](#).

A revised version of Page 3 of the Regular Council Minutes of May 28, 2007, with the addition of a paragraph beneath Item 4, was circulated on table.

MOVED and SECONDED

THAT the minutes of the Regular Council meeting held on May 28, be received and adopted as amended.

PRESENTATION

2. Senior Services Society re outcomes of the Seniors Services Task Force.

Val MacDonald from the Seniors Services Society made a presentation on the outcomes of the Seniors Services Task Force. She outlined the support, participation, and response to the survey. Issues which were identified included access to counseling services, health care, information and housing services, and transportation. She reviewed the wishes of seniors: seniors wish to remain in the community when retirement comes, they wish to remain in their homes with necessary support including appropriate transportation, they need improved information about resources and what benefits they may access and how to do so. Results included: types of housing desired (seniors and adult housing), health status of respondents, there is a strong desire to not ask for help, support services and unmet needs were identified, transportation is needed. Ms. MacDonald listed the 8 recommendations which arose from the survey. She concluded by asking Council to endorse the report and its implementation. Ms. MacDonald circulated her presentation (which will be added to the Agenda package).

DELEGATIONS

3. Delegations re Development Permit 024 (Q) with variances (Parcel 3B Port Royal Development)

David Ropell, Aragon Developments, and Bob Worden, Ramsay Worden Architects, reviewed the following for the project at Parcel 3B in the Port Royal development:

- Site planning and context
- Pedestrian connections via the development of three public walkways
- Landscaping
- Building character with brick, large windows, tall ceilings, etc.

To explain the variances, the delegates reviewed the following:

- Site specific considerations that affect the height and which allow for 10 foot ceiling heights
- Lofts and roof top gardens that affect height
- Demonstration of height lines for the project and in relation to the neighbouring building
- Side yard setback variances, noting that the neighbouring building is 175 feet away from the proposed building; variances do not affect the public park to be built.

Carol Albertson, owner of Griff Building Supplies Ltd., was present to support the development stating that the proposed variances will not impact negatively on the neighbours. She described the development as attractive.

4. Open Delegations

Tony Antonias of 805 Fourth Street announced upcoming Canada Day festivities, noting that the Royal City Record will print an eight pages insert on June 27th announcing the event. Mr. Antonias reviewed the entertainment, refreshments, prizes, lunch box auction, children's activities, location and date/time for the event and invited all to participate.

Christopher Bell of 1006 Nanaimo Street rose to address Zoning Amendment Bylaw No. 7167, 2007, which is the subject of consideration under Item 15. Mr. Bell requested that the project be sent back to staff for a Public Hearing process.

Mr. Jim Lowrie, Acting Director of Engineering Services, advised that the City's Solicitor has advised that Council should not receive delegations on the subject project. Accordingly, Mr. Bell did not continue his presentation. He submitted items of information (which will be added to the Agenda package).

Mr. Lowrie explained that the subject bylaw is a housekeeping bylaw that makes no substantive changes and that the Public hearing can therefore be waived. It is appropriate for Council to consider third reading without a Public Hearing.

Dorothy Beach of 1907 River Drive spoke of the changes taking place in the West End which are having an impact on the community. The changes include the growing number of highways which are cutting residents off from Grimston Park and creating a dependence on driving cars as well as creating a toxic environment from diesel fumes. Scott Paper and River Pile Driving employees are also cut off by the highway. Ms. Beach noted that residents want to continue living in their community and continue to enjoy quality of life.

Ms. Beach stated that the inadequate sewage system is also a serious problem. It is necessary to move from primary to tertiary systems to control the introduction of hot water into the river as this damages fish populations.

David Beach of 1907 River Drive rose to ask for assurance that the community will not be left without a crossing of the new highway at the bottom of Grimston Park at Stewardson Way.

A Council member suggested that the School Board be approached for assistance in securing safe access to their school by the nine children who reside in the community.

Terry Hewitt of 122 First Street rose to address the variance application for 118 First Street. He questioned the process and stated that if there is to be any DVP for 118 First Street, the community wants to be informed, involved and have opportunity for input. Mr. Hewitt's concern was that under no circumstance were there be more than two living units on the site and no secondary suites permitted. He noted there are five electric meters and other features which lead to a concern that more than two living units will be developed.

b) [BC Health Coalition re resolution on home support for BC Seniors Week.](#)

MOVED and SECONDED

WHEREAS home support is a vital part of our health care system that allows seniors, people with disabilities or people with chronic health conditions to live independently and with dignity;

WHEREAS home support has been found to be the most cost-effective program by treating health problems in the home before they develop into chronic health crises requiring hospitalization;

WHEREAS home support promotes healthy living by addressing nutrition and meal preparation, hygiene, grooming, and socialization; and

WHEREAS access to home support has decreased dramatically in the last few years and more generally since 1994, despite an aging population in BC;

WHEREAS we are concerned that the significant cuts to hospital and residential care beds, combined with reduced access to home support, have resulted in a larger burden for home support to address acute needs for fewer patients; and

WHEREAS reduced access to and quality of home support adversely affect the most economically and physically vulnerable populations – namely seniors, particularly women, living alone and on low-incomes; and

WHEREAS home support gives care givers peace of mind and respite;

NOW THEREFORE BE IT RESOLVED THAT the City of New Westminster recognizes and affirms:

- That home support is essential to an efficient and sustainable health care system;
- That home support is fitting with our municipality's image of promoting healthy lifestyles and holistic health;
- That home support is an effective solution to health issues related to our municipality and province's growing senior population;
- That access to home support is equivalent to the right of all individuals to live independently and with dignity; and

BE IT FURTHER RESOLVED THAT the City of New Westminster write a letter to the Premier calling upon the Province of British Columbia:

- To halt further cutbacks and restore home support to 1994 service levels;
- To ensure that home support is a universal program by eliminating user fees and stemming privatization;

- *To overcome staff shortages by improving and standardizing training, implementing competitive wage scales for workers, and developing an active recruitment program for home support workers, including new workers from aboriginal and ethno-cultural communities; and*
- *To create an appeal board for people to dispute their home support assessment that is both impartial and representative of seniors and people with disabilities.*

o) [326 Hospital Street/Demolition Order](#)

MOVED and SECONDED

WHEREAS Section 73 of the Community Charter authorizes Council to impose remedial actions in relations to a building that it considers to be in a hazardous condition;

WHEREAS Section 74 of the Community Charter authorizes Council to declare that a building is a nuisance and to impose remedial actions in relations to the declared nuisance;

WHEREAS Council believes that the building located on property known by the civic address of 326 Hospital Street and more particularly described as NWD GROUP1, PL 2620 NEW WEST DISTRICT GROUP 1, PLAN 2620 LOT 26 OF 8&9, SUBURBAN BLOCK 3 and hereafter referred to as "326 Hospital Street" is unsafe and so dilapidated and unclean as to be offensive to the community and a nuisance; and

WHEREAS 326 Hospital Street is owned by Mr. Devinder S. Mann;

NOW THEREFORE BE IT RESOLVED THAT:

i) (a) Pursuant to Section 73 of the Community Charter and upon Council finding that it considers that the house located at 326 Hospital Street is in an unsafe condition, the following remedial action is imposed: **Building to be demolished and removed by the owner, Mr. Devinder S. Mann, or the owner's agent within 30 days after service of this Order.**

(b) Pursuant to section 74 of the Community Charter and upon Council finding that the house located at 326 Hospital Street is so dilapidated and unclean as to be offensive to the community, 326 Hospital Street is declared to be a nuisance, the following remedial action is imposed: **Building to be demolished and removed by the owner, Mr. Devinder S. Mann, or the owner's agent within 30 days after service of this Order.**

ii) It is hereby further ordered pursuant to section 77 (3) (b) of the Community Charter that:

(a) In the case of default by the owner or agent to comply with this Order, the City, by its employees and others, may enter 326 Hospital Street and effect the demolition and removal of or otherwise dealing with the house on this property at the expense of the owner or owner's agent.

(b) The charges for doing the work under paragraph (a), including all incidental expenses, if unpaid on December 31, 2007, are to be added to and form part of the taxes payable on the land or real property at 326 Hospital Street.
