- Regular Meetings following Public Hearings (“**Regular\***”) will be held to deal with the bylaws considered at the Public Hearings and Opportunities to be Heard. The meetings will be held electronically per Ministerial Order No. M192.

**PUBLIC HEARINGS WILL BE HELD ELECTRONICALLY UNDER MINISTERIAL ORDER NO. M192 UNTIL THE PROVINCIAL STATE OF EMERGENCY ENDS. IN ORDER TO SPEAK ELECTRONICALLY, ADVANCE REGISTRATION IS STRONGLY RECOMMENDED.**
