Ms. Velkova noted that the first meeting is scheduled for March 4, 2015.

Andrea Reyes, Member at large, volunteered to serve as the YAC representative to sit on the Canada Day Subcommittee.

3.2 'Wait for Me Daddy' Initiative

Ruby Campbell, Community Projects Coordinator, provided an overview of the history of the Wait for Me Daddy photograph, as well as a clip of the activities that occurred at the Wait for Me Daddy event held in New Westminster on October 2014, whereby a statue depicting the photograph was unveiled. Ms. Campbell advised that the clip can be found on the project's website at www.waitformedaddy.com.

Ms. Campbell provided a summary with respect to the origins of the initiative, as well as the processes involved that contributed to the completion of the project.

Ms. Campbell reported that there will be an additional Wait for Me Daddy event held in the future, which will engage the community and showcase the history of the site.

Councillor Patrick Johnstone, City Council, provided an overview of the upcoming referendum regarding the Mayors' Council vision and action plan for Metro Vancouver's transportation system. Councillor Johnstone advised that Council is endorsing the plan, suggesting that it will have significant benefits for New Westminster that will reduce congestion, improve transit service, and create a more livable community. Councillor Johnstone advised that, beginning March 16, 2015, ballots will be arriving in the mail whereby residents will have the opportunity to vote on the plan.

6.3 District Parent Advisory Committee (DPAC) Report

Heather Lynch, DPAC, advised that DPAC is organizing an event for parents of students regarding social media.

Ms. Lynch noted that, at the last DPAC meeting, the Committee discussed the Vote 'Yes' campaign for Metro Vancouver's upcoming transit referendum. Threat assessment protocols utilized to address high-risk individuals entering local schools were also discussed.

6.4 Youth Coordinator's Report

6.5 School District #40 Trustee Report

Mark Gifford, School District #40 Trustee, provided an overview of the mandate and operation of the School Board, and noted the following information:

- Board meetings are held monthly and are open to the public;
- The Board is endorsing the Mayor's Council vision and action plan for Metro Vancouver's transportation system;
- The Board is currently investigating ways to transform teaching practices to better recognize diverse needs of students; and,
- The community will be provided with input opportunities during the redesign process of School District #40's logo.
