Two elements are: free transit for all children and youth aged 0-18 and a sliding scale pass for adults based on income. The campaign has a multi-faceted approach focusing on social, economic and environmental justice. The work to increase the uptake of government RESPs is now focused on marketing and outreach work. There are 1,859 eligible children in New Westminster who are not signed up for the Canada Learning Bond as of March 31, 2018. 55.3% of eligible children in New Westminster have been signed up for the Canada Learning Bond, compared with 37.3% of eligible children Canada-wide.

SJ and LP have done some preliminary research on the [poverty screening tool](#). SJ has reached out to the Division of Family Practice who would consider introducing the tool in the future. **Action:** SJ and JS will follow up at the Healthy Community Partnership meeting to see if the tool can be adapted.
