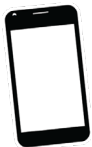
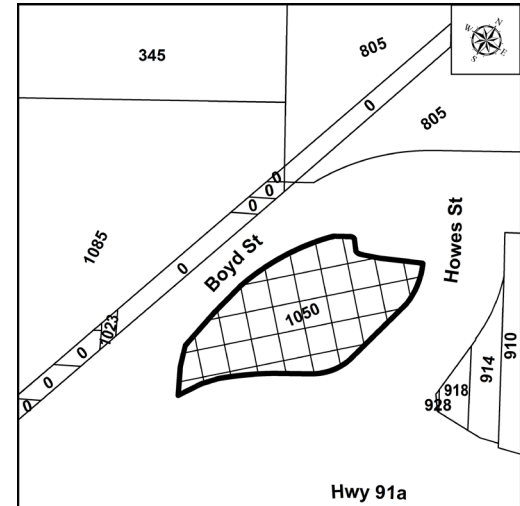
Development Variance Permit for 1050 Boyd Street (DVP00660)

MONDAY, FEBRUARY 25, 2019, AT 6:00 P.M.

Council Chamber, Second Floor of City Hall, 511 Royal Avenue

An application has been received to vary Sign Bylaw 7867, 2017 at 1050 Boyd Street. The variances would allow for the following increases:

1. Number of fascia signs. The maximum number of fascia signs allowed on a street fronting wall is one. Three fascia signs on the south elevation and two fascia signs on both the west and north elevations are proposed.
2. Sign area of directional signs. The maximum permitted sign area for a directional sign is 0.5 sq. m. (5.4 sq. ft.) Two directional signs of 1.5 sq. m. (16.14 sq. ft.) in size are proposed.
3. Height and sign area of freestanding signs. The maximum freestanding sign face area is 15.0 sq. m (161.4 sq. ft.) and the height is 6.0 m (19.7 ft). A freestanding sign of 36.88 sq. m. (397 sq. ft.) in area with a height of 12.1 m (39.7 ft) is proposed.
