BYLAW NO. 7925, 2017

A bylaw to adopt an Official Community Plan

WHEREAS:

The Council has specifically considered whether consultation regarding this Bylaw is required with:

- i. the board of the Metro Vancouver Regional District;
 - ii. the councils of the cities of Surrey, Richmond, and Burnaby and the Corporation of Delta;
 - iii. the Qayqayt First Nation;
 - iv. the Board of Trustees of School District No. 40;
 - v. the boards of the Greater Vancouver Water District and the Greater Vancouver Sewerage and Drainage District;
 - vi. the Provincial and federal governments and their agencies;
- and whether such consultation, if required, should be early or ongoing.

The Council has, between first and second reading of this Bylaw, considered the official community plan adopted by this Bylaw in conjunction with:

- i. the City's Capital Expenditure Program (as contained in the Five Year Financial Plan (2017 - 2021) Bylaw No. 7906, 2017), and
- ii. the 2012 Integrated Solid Waste and Resource Management Plan and the 2010 Integrated Liquid Waste and Resource Management Plan of the Metro Vancouver Regional District.

The Council has consulted with the Board of Trustees of School District No.40 regarding the official community plan adopted by this Bylaw and has sought its input as to the matters set out in s. 476(1) of the *Local Government Act*.

The Council has held a Public Hearing on this Bylaw.

The City wishes to replace the official community plans adopted by Official Community Plan Designation (Brow of the Hill) Bylaw No. 6533, 1999; Official Community Plan Designation Amendment (Brunette Creek) Bylaw No. 6741, 2002; Official Community Plan Designation Amendment (Lower Twelfth Street Area Plan) Bylaw No. 6958, 2004; and Official Community Plan Bylaw No. 7435, 2011.

NOW THEREFORE the Council of the City in open meeting assembled enacts as follows:

1. This Bylaw may be cited as Official Community Plan Bylaw No. 7925, 2017.

2. Council adopts Schedule 1 as the New Westminster Official Community Plan, replacing the official community plans adopted by Official Community Plan Designation (Brow of the Hill) Bylaw No. 6533, 1999; Official Community Plan Designation Amendment (Brunette Creek) Bylaw No. 6741, 2002; Official Community Plan Designation Amendment (Lower Twelfth Street Area Plan) Bylaw No. 6958, 2004; and Official Community Plan Bylaw No. 7435, 2011.

3. This bylaw shall come into force on the date of adoption.
