#### **Working Group Meeting Notes:**

#### **Building Code Q & A**

Joan Drabyk, from the Building Division, answered questions from the Group with regard to the Building Code, and Julie Schueck answered questions with regard to the Zoning Bylaw. Some questions and comments included:

"Builders are uneasy about taking on renovations as it often instigates unexpected upgrades, which leads to people preferring to demo rather than renovate. Can something be done to make the permit process easier and are there ways to not instigate upgrades?"

"More people want to save the interiors of their houses."

"Is it really necessary that people have to provide floor plans for the entire house when they are seeking permits for minor work?"

"How can we encourage people to get permits rather than do the work without?"

#### **Research Sub-Groups**

The sub-group teams were reviewed and everyone present agreed to the distribution of people. Groups were advised to pick a team-leader who would be responsible for calling meetings, coordinating information with Ms. Schueck, and for presenting updates to the larger working group. All research is expected to be completed by the end of January 2015.

#### **Open House Preparation**

The first open house will take place at the Anvil Centre (room 411), on Wednesday, October 29, 2014, from 5:00 – 8:00pm. All members are expected to be present and to engage the public.

The revised questionnaire was reviewed and suggestions were made. The final version will be presented to the group at the next meeting.

#### **Speaker Series**

It was agreed that the speaker series could take place January, February and March 2015 and that they would take place on the same evening as the working group meetings. The working group would meet from 6:00 – 7:00pm in their regular meeting room, then relocate to Council Chambers for the speaker. The speaker series would be open to the public and advertised ahead of time.

Suggestions for the speaker series are Jim Wolf (local historian and urban planner), Don Luxton (Heritage Professional), someone from the Assessment Authority, someone from the insurance industry (an actuary), and someone from Kelowna to talk about their experiences there.

Wendy Sarkissian (international social planner and community engagement specialist) will be speaking to the working group at the November 27 meeting.
